Any citizen of the United States 18 years of age or older may become a member of this Club after submitting a completed, signed membership application and waiver agreement, subscribing to the following Club Pledge, payment in full of the usual initiation fee and dues, and acceptance by approval of the Executive Committee. Applications shall be deemed approved unless subsequently rejected by a majority vote of the Executive Committee. Membership term runs from January 1 through December 31.

Membership cards will be given to new members upon completion of the range orientation briefing. Range orientation briefings are held at the JRGC range on the second Monday of the month starting promptly at 5:45pm, or call an officer to schedule an appointment.
